

Parcel No. 1, Serial # 06-096-0047

Part of the Southeast Quarter of Section 10, Township 5 North, Range 1 West of the Salt Lake Base & Meridian, United States Survey. Beginning at the Southeast Corner of Lot 28, Forest Green Estates Subdivision in Ogden City, Weber County, Utah; and running thence North 0°37' East 38.69 feet to the most easterly corner of said Lot 28; thence South 89°23' East 136.77 feet, more or less, to a point on the Grantor's East property line; thence South 0°37' West 38.69 feet along the Grantor's said East property line; thence North 89°23' West 136.77 feet to the point of beginning.
