A parcel of land for a ramp road incident to the construction of an expressway known as Project No. 0144, being part of an entire tract of property, in Lot 2, Block 11, Ten Acre Plat "A:, Big Field Survey. The boundaries of said parcel are described as follows:

Beginning at the intersection of the westerly no-access line of ahighway known as Project 1-15 and the north property line of ahighway known as Project No. S-0144, which point is 55.0 feet northerly along the east line of said Lot 2 from the center line of survey of said highway known as Project S-0144, said point also being 115.44 feet north from the SE. corner of said Lot 2; thence Northerly 20.8 feet, along said east line of Lot 2; thence S. 81° 22' 10"W.
