SUPPLEMENTAL DECLARATION OF PHASE 25 TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF CLEARWATER COVE A PLANNED RESIDENTIAL UNIT DEVELOPMENT
