



COMMENCING at a point 6 rods (99.0) feet East from the Southwest corner of the Southeast quarter, Section 24, Township 2 South, Range 1 West, Salt Lake Base & Meridian, and running*thence North 2° 15' West 44.04 rods (726.66 feet); thence West 142.05 feet to the Northeast corner of that certain property conveyed in Special Warranty recorded as Entry No. 2211436 in Book 2582 at page 15 of Official Records; thence ^{South} 1953.0 feet, more or less, to the North line of Highway known as Project No. 0150 as conveyed to Salt Lake County in Warranty Deed recorded as Entry No. 2031551 in Book 2243 at page 502 of Official Records; thence along said North line South 87° 13' 58" East 54.0 feet, more or less, to a point of tangency opposite Engineer's Station 6+88.21, with a 22,871.81 foot radius curve to the left; thence Easterly 157.0 feet, more or less, along the arc of said curve to the East boundary of that certain property conveyed in Special Warranty Deed recorded as Entry No. 2211436 in Book 2582 at page 15 of Official Records; thence North 0° 20' East 1247.3 feet, more or less, to point of BEGINNING.

EXCEPTING therefrom a parcel of land conveyed to the State Road Commission in that certain Warranty Deed recorded as Entry No. 2187710 in Book 2528 at page 434 of Official Records, more particularly described as follows:
