Commencing at a point Fourteen (14) feet East of the South-west corner of Lot one (1), Block Sixteen (16), Plat "A", Logan City Survey, and running thence North Fourteen (14) rods, Eleven and one-half (11-1/2) feet; thence East Sixty-four and one-half (64-1/2) feet; thence Southerly in a straight line Fourteen (14) rods, Eleven and one-half (11-1/2) feet, more or less, to a point on the south line of said Lot one, Sixty-four and one-half (64-1/2) feet to the place of beginning, thence West for private driveway over a strip Eight (8) feet wide off the East side of above described land, and conveying any and all water, water rights, irrigating ditches, aqueducts, canals, appropriations, franchises and privileges owned by said party of the first part, or belonging to or with, leading to, connected with, or usually had and enjoyed in connection with said premises.✓


## WARRANTY DEED
