The defendant shall develop and abide by a case action plan.

The defendant shall submit to DNA testing and pay the \$150 fee to the collecting agency, unless already done so.

The defendant shall enter into and complete a substance abuse evaluation through a licensed provider and shall complete any treatment recommended.

The defendant shall pay a \$250 fine. The fine is suspended upon successful completion of probation.

The defendant shall pay a \$250 public defender fee.

The defendant shall not commit any new or like crimes during the period of probation.

The defendant shall not enter any Best Buy stores while on probation.

The defendant shall pay \$699.99 in restitution to Best Buy.

The defendant's probation may be transferred to Tooele County AP&P after the initial contact with Ogden AP&P.
