## ORDINANCE NO. 1982-1

AN ORDINANCE OF RICHFIELD CITY ADOPTING A REDEVELOPMENT PLAN AS THE OFFICAL REDEVELOPMENT PLAN FOR THE REDEVELOPMENT PROJECT AREA NUMBER ONE, LOCATED IN THE CITY OF RICHFIELD, COUNTY OF SEVIER, STATE OF UTAH AND MORE PAR-TICULARLY DESCRIBED IN THE BODY OF THIS ORDINANCE; DESCRIBING THE PURPOSES AND INTENT OF THE CITY COUNCIL WITH RESPECT TO THE DEVELOPMENT/REDEVELOP-MENT OF THE PROJECT AREA; INCORPORATING BY REFERENCE THE REDEVELOPMENT PLAN FOR THE PROJECT AREA; FINDINGS AND DETERMINATIONS OF THE CITY COUNCIL BASED ON FACT THAT: THE PROJECT AREA IS A BLIGHTED AREA, THE REDEVELOPMENT OF WHICH IS NECESSARY TO EFFECUATE THE PURPOSES OF THE UTAH NEIGHBORHOOD DEVELOPMENT ACT, UTAH CODE ANN. SECTION 11-19-1 ET SEQ., AS AMENDED; THE REDEVELOPMENT PLAN WILL REDEVELOP THE PROJECT AREA IN CONFORMITY WITH AND WILL EFFECUATE THE PURPOSES AND POLICIES OF THE AFOREMENTIONED ACT AND WILL PROMOTE THE PUBLIC PEACE, HEALTH, SAFETY, AND WELFARE; THE ACCOMPLISHMENT OF THE REDEVELOPMENT PLAN IS ECONOMICALLY SOUND AND FEASIBLE; ANY CONDEMNA-TION ACCOMPLISHED UNDER THE REDEVELOPMENT PLAN IS NECESSARY TO THE EXECUTION OF THE PLAN AND ADEQUATE PROVISIONS FOR PAYMENT OF ACQUIRED PROPERTY, AS PROVIDED BY LAW, HAVE BEEN MADE; THE REDEVELOPMENT PLAN EMPLOYS A REASONABLE METHOD FOR THE RELOCATION OF DISPLACED PERSONS AND BUSINESSES; THERE ARE IN THE AREA DESIRABLE, SAFE, DECENT, AND SANITARY HOUSING AVAILABLE FOR ALL DISPLACED PERSONS; THE CITY COUNCIL IS SATISFIED THAT PERMANENT HOUSING WILL BE AVIALABLE WITIN THREE YEARS FROM THE TIME PERONS ARE DISPLACED AND UNTIL SUCH TIME, ADEQUATE HOUSING AT REASONABLE RENTS ARE AVAILABLE.

The City Council of Richfield City hereby ordains:

Section 1. The redevelopment plan as formulated by the Richfield Neighborhood Development Agency for the Richfield Redevelopment Project Area Number One is hereby approved and adopted as the official redevelopment plan for the aforementioned project area, which project area is a part of the City of Richfield, the County of Sevier, the State of Utah, and is more particularly described as follows:
