MEMORANDUM OF LEASE

Notice is hereby given that Riverdale Center IV, L.C., a Utah limited liability company ("Landlord") having an address of Riverdale Center IV, L.C. c/o The Boyner Company, 90 South 400 West, Suite 200, Salt Lake City, Utah 84101, and Ulta Salon, Cosmetics & Fragrance, Inc., a Delaware corporation ("Tenant") having an address of Windham Lakes Business Park, 1135 Arbor Drive, Romeoville, Illinois 60446, have entered into a Shopping Center Lease (the "Lease"), dated Yach 3rd, 2008, pertaining to certain premises located within the real property described in Exhibit A attached hereto (the "Shopping Center"), known as Store No. 371. The initial term of such Lease is ten (10) years, and Tenant has the option to extend such term for up to three (3) renewal periods of five (5) years each. Among other things, the Lease grants to Tenant the right along with Landlord and other tenants in the Shopping Center to use the Common Area of the Shopping Center, including without limitation roads, driveways, sidewalks and parking areas, grants certain rights with respect to Landlord's pylon sign structures, and, prohibits other tenants from engaging in (i) the retail sale of cosmetics, fragrances, health and beauty products, hair care products and accessories; personal care appliances; skin care products, and body care products; (ii) the operation of a full service beauty salon with spa services; and (iii) the sale of related goods and services, all as detailed more fully in the Lease.
