acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:

Lot 404 Mount Olympus Park NO. 4 Subdivision. Found in Section 1, T2S, R1E, S L Mer.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:

Running East and west Parallel to and within 5 feet of the North Property line of
Lot 404, Mount Olympus Park No. 4 Subdivision.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantors to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.

Note: Sewer trench to be dug and back filled by hand.
