CITY, a municipal corporation of the State of Utah, GRANTEE, in
consideration of the sum of TEN AND NO/100 (\$10.00) DOLLARS, and
other valuable consideration, a perpetual right of way and ease-
ment for the installation, maintenance, replacement and repair
of water mains, water service lines and water meters for Water
Main Extension 33-C - 772, "Golden Hills Canyon Subdivision,"
on Golden Hills Canyon Road, east of Kings Hill Drive (about
8780 South and 3745 East), over, under and across the following
described tract of land situated in Salt Lake County, State of
Utah, to-wit:

A 20 foot easement and right of way 10 feet on each
side of the following described center line:

Beginning at the Southwest corner of Lot 1, Golden
Hills Canyon, a subdivision in the Northwest Quarter
of Section 1, Township 3 South, Range 1 East, Salt
Lake Base and Meridian; thence running North 70°
32' 30" East 151.42 feet to the point of curve of a
177.315 foot radius curve to the right; thence
easterly along the arc of said curve 119.02 feet;
thence South 71° East 50.46 feet to the point of
curve of a 153.158 foot radius curve to the left;
thence Easterly along the arc of said curve 80.19 feet;
thence North 79° East 327.10 feet to the point of
curve of a 240 foot radius curve to the right; thence
easterly along the arc of said curve 115.91 feet to
the point of compound curve of a 50 foot radius curve
to the right whose tangent at said point bears South
73° 19' 46" East; thence Southeasterly along the arc
of said curve 33.01 feet; thence South 35° 30' East
91.88 feet to the east line of Lot 7, said Golden
Hills Canyon Subdivision;

together with the right of ingress and egress.

The Grantor may use the surface of said tract for purposes
that will not interfere with the use thereof by the Grantee, but
will not erect any structure or building over or upon said tract
of land.
