DEED OF EASEMENT
Davis County

The UTAH DEPARTMENT OF TRANSPORTATION, by its duly appointed Director of Right of Way, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, Grantor, herein referred to as Grantor, Grants and Conveys to the WEBER BASIN WATER CONSERVANCY DISTRICT, Grantee, for the sum of One Dollar and other good and valuable consideration, the receipt of which is hereby acknowledged, a perpetual easement including ingress/egress to construct, reconstruct, operate and maintain an underground pipeline or pipelines and other related appurtenant structures on, over, or across the following described property:

PART OF THE GRANTOR'S ENTIRE TRACT OF PROPERTY, SITUATE IN THE SOUTHEAST QUARTER AND THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 13, TOWNSHIP 3 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE WESTERLY HIGHWAY RIGHT OF WAY AND NO-ACCESS LINE OF LEGACY PARKWAY HIGHWAY, SAID POINT BEING NORTH 89°48'27" EAST 1296.92 FEET ALONG THE SECTION LINE TO SAID WESTERLY HIGHWAY RIGHT OF WAY AND NO-ACCESS LINE AND NORTH 50°30'35" WEST 153.20 FEET ALONG SAID WESTERLY HIGHWAY RIGHT OF WAY AND NO-ACCESS LINE FROM THE SOUTHWEST CORNER OF SAID SECTION 13; AND RUNNING THENCE NORTH 50°30'35" WEST 15.05 FEET ALONG SAID WESTERLY HIGHWAY RIGHT OF WAY AND NO-ACCESS LINE TO THE SOUTH LINE OF AN EASEMENT DESCRIBED IN BOOK 244 PAGE 623; THENCE NORTH 88°56'00" EAST 525.23 FEET ALONG THE SOUTH LINE OF THE SAME EASEMENT DESCRIBED IN BOOK 244 PAGE 623; THENCE SOUTH 50°17'20" EAST 14.98 FEET ALONG THE WEST LINE OF AN EASEMENT DESCRIBED IN BOOK 338 PAGE 230; THENCE SOUTH 88°56'00" WEST 525.14 FEET TO THE POINT OF BEGINNING. CONTAINS 5139 SQUARE FEET OR 0.12 ACRES.

Grantor shall, subject to Grantee's rights as herein granted, have the right to fully enjoy and use the premises burdened by said easement, but Grantor, its successors and assigns, shall not erect any permanent buildings, structures, or place trees upon lands comprising the perpetual easement without the Grantee's consent in writing. Notwithstanding the foregoing, Grantor, its successors and assigns, shall have the right to enter into agreements relating to and impacting the easement area set forth herein, subject to the prior written consent of Grantee, which consent shall not be unreasonably withheld.

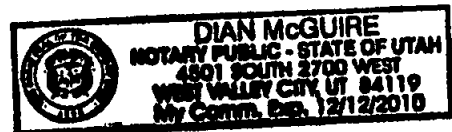
