Gentlemen:

Plans and supporting information on the water supply and wastewater disposal facilities for the above referred development have been submitted for our review as to the feasibility of supplying these services. The following comments reflect our review of the information submitted.

Wastewater Disposal Facilities

Based on soil information and percolation tests, it is our opinion that installation of subsurface wastewater disposal systems in this subdivision is feasible providing the following conditions are complied with:

1. Lots 9 and 11 have not had individual soil exploration and percolation tests conducted. Lots 9 and 11 will not be given in this subdivision unless the soil tests are satisfactory.
2. All lots must have plot plans approved by the health department. Because of the terrain of the area, an inspection for location of sewage system and building must be made by the health department before a building permit is issued. Once plot plans are approved, they must be strictly adhered to.
3. Approval of individual disposal systems will be given only after an inspection of each installation by a representative of the health department, following construction and installation, but prior to backfilling.
4. Each wastewater disposal system must be installed in compliance with the Utah State Department of Health "Code of Waste Disposal Regulations" Part IV, Individual Wastewater Disposal Systems.

5. Subsurface wastewater disposal systems must be kept a minimum of 100 feet from any irrigation ditch, drain or underground drain.

Water Supply

The water supply to the Pine Creek Subdivision will be an extension of the North Fork Special Service District. This water supply is rated by the Utah State Bureau of Public Water Supplies as "not approved--corrective action." Progress must be made to correct the problems and be rated "approved."

It appears that sufficient water will be available at adequate pressure to serve the development (State Health Department letter dated March 11, 1983). Water lines should be disinfected according to the Utah State Division of Health publication "Disinfection of Public Water Supply Systems" or a AWWA Standard C601-68.
