

MINERAL DEED

This deed dated July 7<sup>th</sup>, 1987 from Baca Petroleum Corp. ("Grantor"), an Arizona corporation, formerly known as AZL Petroleum Corp., to The Baca Corporation ("Grantee"), a Delaware corporation.

For \$100.00, and other good and valuable consideration, the receipt and adequacy of which are acknowledged, Grantor has granted, bargained, sold and conveyed, and hereby does grant, bargain, sell and convey unto Grantee, its successors and assigns forever, all of Grantor's right, title and interest in and to all oil, gas (gas for all purposes being defined without limitation to include dry gas, casinghead gas, distillate, condensate, carbon dioxide, helium and all other gaseous substances), coal, oil shale, and all other solid, liquid and gaseous hydrocarbons located upon, beneath the surface of, or within the lands identified in Exhibit A attached hereto, together with the right of ingress and egress and use of the said lands as reasonably necessary for the exploration, development, production, treatment, storage and transportation of such substances to be produced from the said lands, including the conduct of seismic operations, the drilling and operation of wells, mining by underground or surface methods, and installation and operation of storage facilities, roads, pipelines, utilities and other reasonable facilities.

This deed includes the rights of Grantor in and to all leases, farmout agreements, and other contracts or agreements for exploration, development, operation, unitization or communitization relating to the exploration, development, production and sale of such substances.
