WARRANTY DEED OF EASEMENT by Deputy

RAY E. AUSTIN and FAY D. AUSTIN, his wife, DON ROZEMA and BESSIE P. ROZEMA, his wife, HARRY ROZEMA and BESSIE ROZEMA, his wife, KURT A. SCHROEDER, also known as K.A. SCHROEDER, IRENE HALE SCHROEDER, also known as IRENE SCHROEDER, his wife, and ROZEMA AND AUSTIN, a Partnership, Grantors of Salt Lake County, State of Utah, hereby convey and warrant to the UNITED STATES OF AMERICA, Grantee, acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat. 388), and acts amendatory thereof or supplementary thereto, for the sum of Four Thousand Eight Hundred Fifty and No/100 Dollars (\$4,850.00), the following described tracts of land in Salt Lake County, State of Utah:

A perpetual easement to construct, reconstruct, operate and maintain an underground pipeline or pipelines and appurtenant structures on, over, or across the following described property:
