

Utah, and being twenty-five (25) feet on each side of the following described center line:

Beginning at fence on north boundary line of said land at a point 1320 feet north and 1940 feet west, more or less, from the southeast corner of Section 35, T. 4 S., R. 1 W., S.L.B.& M., thence running S.18°33'E. 1381 feet to south boundary line of said land at north fence line of County Road and being in the SW 1/4 of the SE 1/4 of said Section 35.
