BOUNDARY LINE AGREEMENT

This Boundary Line Agreement is entered into by the parties described herein below ("Parties"), and is intended to run with the land and bind all of the respective successors-in-interest of the Parties as further described herein.

This Boundary Line Agreement is entered into in exchange for sufficient consideration, the receipt of which is hereby acknowledged.

George Pyper Henderson and Carolynne J. Henderson are the owners of the following-described parcel and tract of real property, situated in Weber County, State of Utah:

PART OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 29, TOWNSHIP 7 NORTH, RANGE 1 EAST, SALT LAKE MERIDIAN, U.S. SURVEY: BEGINNING AT THE NORTHEAST CORNER OF SAID SOUTHWEST QUARTER SECTION, AND RUNNING THENCE SOUTH 240 FEET, THENCE WEST 525.00 FEET, THENCE SOUTH 560 FEET, THENCE EAST 470.00 FEET, MORE OR LESS, TO THE WEST LINE OF 3500 EAST STREET; THENCE SOUTH 220 FEET; THENCE WEST 290.4 FEET; THENCE SOUTH 300 FEET; THENCE WEST 1095.60 FEET; THENCE NORTH 4D48'24" EAST 1324.66 FEET ALONG FENCE TO SECTION LINE; THENCE EAST ALONG SECTION LINE 1330/FEET, MORE OR LESS, TO THE POINT OF BEGINNING. The Parties acknowledge that historically there have existed physical monuments demarking the respective occupancies of the respective parcels, and that at some times these monuments have not been consistent with the actual boundary line between the properties as described and awarded in the Divorce Decree.

The Parties hereby agree that conflicting monuments notwithstanding, the true boundary between the respective parcels set forth herein is described as follows:

BEGINNING AT THE SOUTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 7 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY; RUNNING THENCE WEST 1320 FEET TO END.

The Parties waive any and all claims for any differing boundaries by acquiescence, by easement (prescriptive or otherwise), by use, occupancy, adverse possession, or by any other theory which would be inconsistent with the described boundary set forth hereinabove. The Parties intend this agreement and acknowledgement and waiver to be binding upon their respective successors-ininterest to their respective parcels as described herein.
