PARCEL 1: A PART OF THE SOUTHWEST QUARTER OF SECTION 30, TOWNSHIP 6 NORTH, RANGE 1 WEST, SALT LAKE MERIDIAN, U.S. SURVEY: BEGINNING AT A POINT 20.96 CHAINS EAST AND 6 CHAINS NORTH FROM THE SOUTHWEST CORNER OF SAID QUARTER SECTION, AND RUNNING THENCE EAST 75 FEET; THENCE NORTH 132 FEET; THENCE WEST 75 FEET; THENCE SOUTH 132 FEET TO THE PLACE OF BEGINNING.
