To all to Whom these presents shall come, Greeting:

Whereas, a Certificate of the Register of the Land Office at Salt Lake City, Utah has been deposited in the General Land Office, whereby it appears that, pursuant to the Act of Congress of May 20, 1862, "To Secure Homesteads to Actual Settlers on the Public Domain", and the acts supplemental thereto, the claim of Alvin Hall has been established and duly consummated, in conformity to law, for the Lots one, two, six, seven, eight, eleven and twelve and the northwest quarter of the northeast quarter of Section nineteen in Township forty-two south of Range eleven West of the Salt Lake Meridian, Utah, containing three hundred twenty acres, according to the Official Plat of the Survey of the said Land, returned to the General Land Office, by the Surveyor-General:

Now Know Ye, That h there is, therefore granted by the United States unto the said claimant the tract of Land above described: To Have and to Hold the said tract of land, with the appurtenances thereof, unto the said claimant and to the heirs and assigns of the said claimant forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the Land Office, State, and Law.
