# Quit Claim Deed

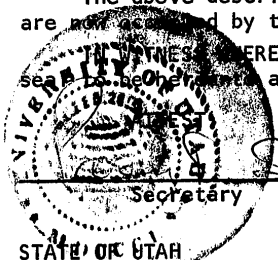
UNIVERSITY OF UTAH, a body politic, organized and existing under the laws of the State of Utah, with its principal office at Salt Lake City, County of Salt Lake, State of Utah, Grantor, hereby QUIT CLAIMS to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of ten Dollars, the following described parcel of land in Salt Lake County, State of Utah, to-wit:

A parcel of land in fee for a highway known as Project No. T-1001, being part of an entire tract of property, in unsurveyed Section 4, T. 1 S., R. 1 E., S.L.B.&M., and being within the original Fort Douglas Military Reservation. The boundaries of said parcel of land are described as follows:

Beginning at Survey Marker "33-18" of Tract "D" of said unsurveyed Section 4; thence S. 22°08'50" E. 737.12 ft. to a point of tangency with a 700-foot radius curve to the right, said point is Survey Marker "34-17" of said Tract "D"; thence Southerly 141.44 ft. along the arc of said curve to Survey Marker "35-16" of said Tract "D"; thence S. 10°34'10" E. 377.88 ft. to a point of tangency with a 2000-foot radius curve to the left, said point is Survey Marker "36-15" of said Tract "D"; thence Southerly 70.04 ft. along the arc of said curve; thence S. 76°09'16" W. 61.87 ft.; thence S. 55°40'00" W. 459.76 ft. along the southeasterly right of way line of Hempstead Road; thence N. 34°20'00" W. 100 ft.; thence N. 55°40'00" E. 426.10 ft. along the northwesterly right of way line of said Hempstead Road to a point of tangency with a 120-foot radius curve to the left; thence Northeasterly 66.73 ft. along the arc of said curve; thence Northerly 27.66 ft. along the arc of a 96-foot radius curve to the left (Note: Tangent to said curve at the point of beginning bears N. 05°56'24" E.); thence N. 10°34'10" W. 216.10 ft. to a point of tangency with a 914.93-foot radius curve to the left; thence Northerly 172.76 ft. along the arc of said curve; thence N. 21°23'17" W. 787.86 ft. to a point of tangency with a 778.51-foot radius curve to the left; thence Northwesterly 167.15 ft. along the arc of said curve; thence N. 33°41'24" W. 270.11 ft.; thence N. 43°56'24" W. 141.10 ft.; thence N. 46°03'36" E. 60 ft.; thence S. 43°56'24" E. 167.56 ft. to a point of tangency with an 1175.92-foot radius curve to the right; thence Southeasterly 278.85 ft. along the arc of said curve to a point of reverse curve; thence Southeasterly to Northeasterly 116.11 ft. along the arc of a 50.25-foot radius curve to the left (Note: Tangent at the point of reverse curve bears S. 30°21'11" E.); thence N. 17°14'42" E. 47.39 ft.; thence S. 72°45'18" E. 60 ft.; thence S. 00°01'51" W. 178.27 ft.; thence S. 81°09'30" W. 89.55 ft. to the point of beginning as shown on the official map of said project on file in the office of the State Road Commission of Utah.

The above described parcel of land contains 5.022 acres, of which 4.253 acres are now used by the existing highway. Balance 0.769 acre.

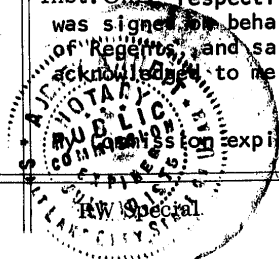
