NOW THEREFORE, in consideration of the premises, the following restrictions are hereby created and declared to be covenants running with the title and the land hereinbefore described, and each and every part thereof, and the undersigned owner hereby declared that the aforesaid land above referred to is to be held and hereinafter conveyed subject to the following reservations, restrictions and covenants hereinafter set forth:

### 1. Persons bound by these Restrictions:

That the covenants and restrictions are to run with the land and all persons and corporations who now own, or shall hereafter acquire any interest in any of the land hereinbefore described or any lot, partion or percel thereof, shall be taken and held to agree and covenant with the owners of the said land and with their heirs and assigns to conform to and observe the following covenants, restrictions and stipulations as to the use thereof, and construction of residences and improvements thereon for a period of twents years from this date.

# ". Use of land, cost, frontage:

That none of said land or fraction thereof, shall be improved, used or occupied for any other than residential purposes, and no store or stores shall be created thereon, PROVIDED, HOWEVER, that these restrictions are unived if consent is given thereto under the provisions of the Zening ordinances of the City of egion.

Said land, or any lart thereof, or any lot thereof, shall be not resubdivided into building lots having less than a width of 60 feet at the front line thereof as berein defined, and in the event of subdivision of any of said

## 7. Saving Clause:

Invalidity of any one of these covenants by judgement or court order shall in no wise effect any of the other provisions which shall remain in full force and effect.

No restriction, or restrictions, shall in any manner take precedent over a mortgage, or mortgages.
