AMENDMENT TO HIDDEN COVE OWNERS' ASSOCIATION
BUILDING REGULATIONS

The Hidden Cove Owners' Association, in a duly called meeting held September 19, 1985, voted to change the original Building Regulations which have previously been recorded on June 9, 1980, Entry No. 167373, Book M160, Page 60-65.

NOW THEREFORE, the following regulations are hereby adopted and are declared to be the building requirements for Section B of the Hidden Cove Owners' Association Building Regulations.

B. SQUARE FOOTAGE REGULATIONS

No single-story family dwelling shall be constructed on any lot in the Hidden Cove Subdivision with a floor space in said single-story dwelling of less than 1,200 square feet on the ground level, excluding garage, carport, patio, attached storage areas and basements.

No two-story family dwelling shall be constructed on any lot in the Hidden Cove Subdivision with a floor space in said two-story dwelling of less than 1,500 square feet exclusive of garage, carport, patio, attached storage areas and basements. The ground floor level shall have at least 750 square feet.

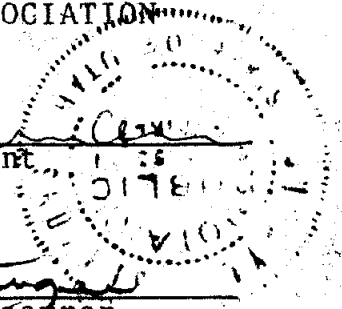

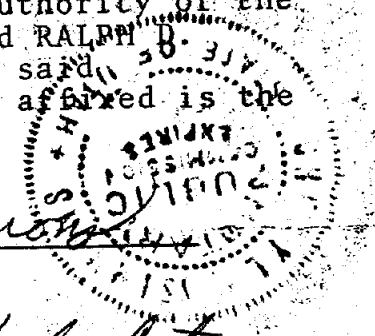
