Beginning at a point 40.11 feet South 88°55'51" West from the Northwest Corner of Lot 77, "Enchanted Hills No. 2", a subdivision located in the Southeast Quarter of Section 26, Township 2 South, Range 1 East, Salt Lake Base & Meridian; thence North 30.0 feet; thence North 88°55'51" East 358.32 feet; thence South 14°00' West 184.10 feet to a point on a curve to the left, the radius of which is South 08°53' West 45.0 feet; thence Westerly along the arc of said curve 21.31 feet; thence North 14°00" East 154.42 feet; thence South 88°55'51" West 330.10 feet to the point of beginning.

Together with the right to operate, repair, replace, maintain and remove said facilities from said premises; to add to or alter said facilities at any time, with access to said easement and ingress therefrom to permit normal operations of the City in connection with said facilities.

Grantor shall not erect or construct or permit to be erected or constructed any building or other structures or drill any well within the limits of said easement, or permit any trees to be planted within the limits of said easement without the prior written consent of City; provided, however, Grantor shall have the right to construct and erect fences within the limits of the easement in a manner which will not unreasonably interfere with City's right of access to its said facilities.

By accepting this easement, City agrees to exercise reasonable care to avoid damage to said premises and all property of Grantee that may at any time be thereon.
