NOTICE FOR SECONDARY WATER USE

The undersigned, **Mountain View Irrigation**, Inc., being a duly organized and operating entity in the State of Utah, does hereby state, stipulate and warrant the following:

1. Entity has created a distribution system for secondary water.

The properties serviced by said distribution system are described on the attached Exhibit "A" which by reference are made a part of this notice.

 The owners of the above described properties are subject to periodic assessments, levied by the undersigned company, for delivery of water and maintenance of the distribution system.

4. Failure to pay the assessments levied by the undersigned for the use of secondary water and the distribution of the same, by the owner of the occupant of the subject properties described on Exhibit "A" will be deemed cause to terminate secondary water services to the subject properties and to file a lien thereon.

5. In the event of disconnect, a reinstatement fee together with the payment in full of past assessments shall be due from the owner of occupant of the subject property, prior to re-establishment of services.
