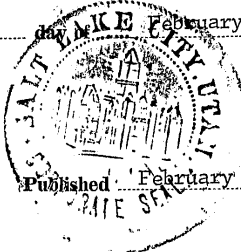

AN ORDINANCE
AN ORDINANCE VACATING a
portion of an alley between Herbert
Avenue and Williams Avenue and be-
tween 3rd and 4th East Streets.

Be it ordained by the Board of
Commissioners of Salt Lake City,
Utah:

SECTION 1. That a portion of an
alley located between Herbert Ave-
nue and Williams Avenue and be-
tween 3rd and 4th East Streets, more
particularly described as follows, be,
and the same hereby is, vacated and
declared no longer to be public prop-
erty for use as a street, avenue, alley
or pedestrian way:

BEGINNING at the Southeast cor-
ner of Lot 42, Block 2, Carolina Sub-
division, a subdivision of part of
Block 20, 5 Acre Plot "A," Big Field
Survey and running thence North
142.0 feet; thence East 10 feet to the
Northwest corner of Lot 43, said
block and subdivision; thence South
142.0 feet to the Southwest corner of
said Lot 43; thence West 10 feet to the
point of beginning. Contains 0.033
acres..

Said vacation is made expressly
subject to all existing rights of way
and easements of all public utilities
of any and every description now
located in, on, under or over the con-
fines of the above described prop-
erty, and also subject to the rights of
entry thereon for the purpose of
maintaining, altering, repairing,
replacing, removing or rerouting said
utilities and all of them.
