A waterline and appurtenances easement situate in Huntsville Town, Weber County, Utah and within the Southwest Quarter of Section 13, Township 6 North, Range 1 East being more particularly described as follows:

Commencing at the corner common to sections 13,14,23 & 24 said township and range marked in place with a BLM brass cap set in 1967 and running thence along the section line between sections 13 and 24 South 89°50'31" East 169.95 feet; thence North 0°09'29" East 509.01 feet to a point on the Southerly boundary of the grantor's property and the **point of beginning** for this description and running thence along and beyond the grantor's South line South 85°23'28" East 45.68 feet; thence North 5°16'50" West 189.84 feet; thence North 47°02'40" West 122.35 feet; thence South 50°30'15" West 64.75 feet; thence South 55°11'30" East 117.70 feet; thence South 5°16'50" East 161.05 feet to the point of beginning.

Description inscribes 14,470 square feet or 0.33 acres more or less.

Also including a waterline within the said Quarter Section being bounded on the West by Edgewater Beach Resort Phase 1 and bounded on the South by the Northerly Right of Way line of Utah State Road 38 and being 10 feet left and 35 feet right of the following described Centerline:

Commencing at the corner common to sections 13,14,23 & 24 said township and range marked in place with a BLM brass cap set in 1967 and running thence along the section line between sections 13 and 24 South 89°50'31" East 323.40 feet; thence North 0°09'29" East 256.46 feet to the **point of beginning** for this centerline and running thence South 74°08'06" East 149.45 feet; thence South 15°01'36" East 45.38 feet; thence South 56°08'24" East 206.45 feet more or less to the North Right of Way line of Utah State Road 38.
