NOTICE OF PRESCRIPTIVE EASEMENT THE SOUTH WEBER IRRIGATION COMPANY

Pursuant to Utah Code Annotated Section 73-1-15, it is unlawful to encroach upon this Easement or to interfere with the water system located thereon. 
