hereby convey and warrant to MORRISON-KNUDSEN COMPANY, INC., a corporation, its successors in interest and assigns, Grantee, for the sum of ~~four thousand~~ ^{forty (40) dollars} Dollars and other valuable consideration, an easement and right of way for the period of five (5) years from the date hereof for the erection and continued maintenance, repair, alteration and replacement of electric transmission, distribution and telephone circuits, and two (2) ~~xxxxxxx~~ poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon the premises of the grantors, in

Weber County, Utah, along a line described as follows:

Beginning on the west boundary line of the grantors' land at a point 3 feet south and 2000 feet west, more or less, from the east one quarter corner of Section 36, T. 6 N., R. 2 W., S.L.M. thence N. 86° 50' E. 551 feet, more or less, to a fence on the east boundary line of said land and being in the NW₄ of the SW₄ and the SW₄ of the NE₄ of said Section 36.

Beginning at a fence on the west boundary line of grantor's land at a point 20 north and 1450 feet west, more or less, from the east one quarter corner of Section 36, T. 6 N., R. 2 W. S.L.M., thence N. 86° 50' E. 80 feet, more or ~~less~~ less, to the east boundary line of said land and being in the SW₄ of the NE₄ of said Section 36.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other natural obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.

Lessee may renew this easement for successive terms of one (1) year each up to five (5) years for a yearly rental

of \$ 8.00, payable in advance, by giving written notice thereof at least sixty (60) days prior to the end of each term.

Lessee may assign this easement as it sees fit.
