Mark William Johnston asserts that the value is \$370,000, while Britnee Carole Johnston asserts that the value is \$420,000. Despite this disagreement, the parties have reached an agreement regarding the division of the property.**

Disposal: The total equity in the marital residence has been calculated, and Britnee Carole Johnston's share is determined to be \$57,605. To reflect this: Britnee Carole Johnston will have an equitable lien against the property in the amount of \$57,605. Upon entry of the Divorce Decree, Mark William Johnston will provide the lump-sum payment of \$57,605 to Britnee Carole Johnston. This payment shall be made concurrently with or prior to Britnee Carole Johnston's execution of a quitclaim deed transferring her ownership interest in the property to Mark William Johnston. Once the payment is made and the quitclaim deed is executed, Mark William Johnston shall be solely responsible for submitting the Divorce Decree, the fully executed quitclaim deed, and the declaration page of the homeowner's insurance policy listing him as the sole insured party to the mortgage company, for the purpose of initiating the process to remove Britnee Carole Johnston's name from the VA mortgage loan. Britnee Carole Johnston shall sign any documents necessary to remove her name from the property title or mortgage documentation, to the extent she is listed but not legally obligated on the VA mortgage loan. No refinance shall be required, as Britnee Carole Johnson agrees to an assumption of the VA mortgage loan by Mark William Johnston, thereby removing her name from the loan. Mark William Johnston shall assume full legal responsibility for the mortgage.
