The Court, having now received the mutually signed stipulated petition for a Decree of Divorce and, having reviewed the file in this matter, for good cause otherwise appearing, now orders as follows:

**Background**

The parties have and intend to maintain a positive relationship with one another, however it is in both their interests to formally sever the legal bond of marriage.

**Jurisdiction and Grounds**

1. Both parties are residents of the state of Utah and have resided here for at least the

last six months prior to filing this petition for Divorce.

2. Both parties hereby seek a no fault divorce.
3. The parties were married on January 16, 2021, in Salt Lake County.
4. The parties have agreed to separate by December 31, 2025, when the marital home will be placed on the market.
5. The marriage is to be dissolved due to irreconcilable differences.

#### **Provisions Relating To Real Property and Vehicles**

6. The real property at issue in this marriage is a marital home located at 3095 Silver Hawk Dr., Holladay, UT 84121. The home will be readied for sale in January of 2026. Home equity will be split equally. Mortgage and utilities paid while the house is on the market to be sold will be split 60% paid by Bartosz and 40% paid by Jennifer. Both parties are vacating the property by the end of December with the house such that the home will be ready to be on the market in early January.

7. Bartosz hereby waives any claim or right to property that Jennifer may purchase prior to the conclusion of this Divorce, said property currently believed to be located on Woodduck Lane.

8. Bartosz will be taking the 2014 Subaru Crosstrek. Jennifer will be taking the 2020 Chevrolet Bolt. Both titles are free and clear with no encumbrances. Jennifer will be removed from the title of the 2014 Subaru Crosstrek.

#### **Provisions Relating to Personal Property**

9. Household goods (furniture, appliances, etc) will be split by both parties as agreed.
10. Each party will retain their personal property, such as watches, jewelry, clothing, etc.,

and as agreed by the parties.

### **Provisions Relating To Financial Assets And Debts**

11. The parties do not have any joint financial Accounts, credit card accounts or other financial accounts that are not in their individual names.

12. Each party will be retaining their retirement accounts with no divisions.

13. The parties are awarded any and all bank accounts in their own names.

14. The parties are awarded any and all pension, profit sharing, brokerage, or other similar accounts in their own names.

### **Children**

20. The parties have no minor children.

### **Tax Provisions**

21. The parties shall file a joint tax return for the 2025 tax year.

22. Beginning with the 2026 tax year, each party will file their own taxes.

### **Name Change**

23. Jennifer Ksok has the right to change her married name.

### **Restraining Order**

24. While both parties have a positive and respectful relationship currently, both parties are mutually restrained from attempting, threatening, or committing domestic violence against the other party, this includes stalking, harassing, or physically harming the other party.

25. The parties have read a Domestic Relations Injunction and agree to be bound by it in the absence of mutual agreement.

### **Divorce**

26. The parties are hereby granted a Divorce.
