**ORDINANCE NO. 2010-53**

**AN ORDINANCE AMENDING ORDINANCE 2010-48 WHICH DELETES THE  
RENAMING OF THAT PORTION OF BURKE LANE WEST OF RED BARN  
LANE TO 1525 WEST FROM BURKE LANE TO STATION PARKWAY**

**WHEREAS**, the governing body of Farmington City has received and considered input from abutting property owners strongly opposing the renaming of Burke Lane west of Red Barn Lane to Station Parkway;

**WHEREAS**, the governing body of Farmington City has determined that there is good cause for amending Ordinance 2010-48 previously passed and that the amendment will not be detrimental to the general interest of the public to grant the same; and

**WHEREAS**, it is the Farmington City Council's intent in the future to rename Burke Lane west of Red Barn Lane to 1525 West from Burke Lane to Station Parkway when changes occur to the alignment of that portion of Burke Lane referred to herein or when development of a future road north of the Burke Lane/1525 West intersection is constructed at the sole discretion of the City Council.


**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
FARMINGTON CITY, STATE OF UTAH:**

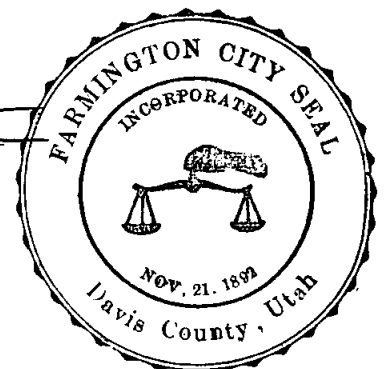
**Section 1. Street Renaming.** The City Council of Farmington City hereby declares that the street known as "Burke Lane" between I-15 and Station Parkway (approximately 1200 West) in Farmington, Utah, as more particularly described the Burke Lane Right-of-Way from I-15 to Station Parkway, is hereby renamed to "Red Barn Lane".

**Section 2. Street Renaming.** The City Council of Farmington City hereby declares that the street known as Burke Lane between Station Parkway (approximately 1200 West) and 1525 West in Farmington, Utah, as more particularly described as Burke Lane Right-of-Way between Station Parkway and 1525 West shall remain as Burke Lane until such time that the City Council determines that a change in name from Burke Lane to Station Parkway is justified by either a realignment of Burke Lane near 1525 West or a new development application is received by the City on any portion of the road.


