ASSIGNMENT AND ASSUMPTION OF DECLARANT'S RIGHTS AND OBLIGATIONS

This Assignment and Assumption of Declarant's Rights and Obligations ("Assignment") is entered into as of _______, 2012 by Acres, L.L.C., a Utah limited liability company ("Acres") and HAI North Ogden Marketplace, LLC, a Utah limited liability company ("HAI").

BACKGROUND

- A. Acres is the Declarant under that certain Declaration of Restrictions, Grant of Easements and Common Facilities Maintenance Agreement dated January 8, 1998 and recorded in the Official Records of Weber County as Entry No. 1515578, in Book 1902, at Page 7 ("Declaration"). Capitalized terms used but not defined in this Assignment will have the respective meanings ascribed to them in the Declaration.
- B. The Declaration encumbers certain property located in Weber County, Utah, and legally described on Exhibit A to this Assignment ("Property").
 - C. Acres is the Declarant under the Declaration.
- D. By deed recorded concurrently with this Assignment, Acres has transferred all of its interest in the Property (which interest only constitutes a portion of the Property) to HAI.
- E. Acres desires to transfer and assign all of its rights and obligations as Declarant under the Declaration to HAI.

AGREEMENT

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

Acres hereby assigns to HAI all of Acres's right, title, and interest as Declarant under the Declaration. HAI hereby accepts the foregoing assignment, designation, and appointment as Declarant and assumes all of the obligations, liabilities, duties, and responsibilities of Acres as Declarant.

Acres and HAI, each for itself, hereby represents and warrants it has the authority to enter into this Assignment and that each undersigned has the authority to execute this agreement on behalf of Acres and HAI, as applicable.
