## OF COVENANTS, CONDITIONS AND RESTRICTIONS

### A CONDOMINIUM PROJECT

THIS SECOND AMENDMENT is made by ARTISTIC HOMES

CORPORATION, a Utah corporation, to the Declaration of Covenants,

Conditions and Restrictions of Monte Cristo, a Condominium Project,

as amended, and is referred to in this Second Amendment and in said

WHEREAS, the Declarant, Unit Owners and financial institutions previously executed a First Amendment to said Declaration clarifying the ownership of the Common Areas and Facilities, the future development of the project and other matters, and

WHEREAS, the Declarant has determined not to develop and construct the apartment house project as referred to in the Declaration and in lieu of the apartment house project desires to construct condominium units which will be sold or rented as the Declarant shall determine, such changes being in accordance with the provisions of Articles IV and VI and other authority as contained

in the Declaration, and

WHEREAS, the Declarant is ready to proceed with the recording of Phase II of said Condominium Project as referred to and authorized in the preamble, definitions and Articles IV and VI of the Declaration, as amended,

NOW THEREFORE, the Declarant does hereby make the following Second Amendment to said Declaration, as amended:

- 1. The next phase of this Condominium Project shall be known as Phase II and shall be in accordance with Exhibit "A", attached hereto and incorporated herein by reference, being the Record of Survey Map of Monte Cristo Phase II, a Condominium Project.
- 2. The real property included within Phase II is situated in Salt Lake County, State of Utah, and is particularly described as follows:

Beginning at a point which is West 665.08 ft. and South 787.64 ft. from the NE corner of Section 21, T2S, R1E, S.L.B.&M., running thence South 222.16 ft.; thence West 528.50 ft.; thence N 0°29'15" E, 233.0 ft.; thence East 271.18 ft.; thence South 10.83 ft.; thence East 255.33 ft. to the point of beginning. Contains: 2.76 acres.

- 3. The Declarant hereby submits the above described tract of land, buildings and other improvements constructed thereon or hereafter to be constructed, together with all appurtenances, to the provisions of the Utah Condominium Ownership Act, which shall be known as Monte Cristo Phase II.
- 4. The development of Phase II will change the initial percentages of ownership of the Common Areas and Facilities and the new percentages for all condominium units now authorized are as set forth in the First Amended Exhibit "B", attached hereto and

and construct the apartment house project as referred to in the Declaration, does hereby eliminate the first "WHEREAS" paragraph on page 2 and Article VIII of the Declaration, together with all other references in the Declaration to the apartment house project which are in conflict with the provisions of this Second Amendment, the same being amended to the extent necessary to achieve conformity. Although the Declarant has the right and power to construct condominium units on the land originally contemplated for the apartment house project, it is under no obligation or duty to do so.
