## POLE LINE EASEMENT

John W. Hillstrom and Elida Hillstrom his wife, Grantors, of Box Elder County, Utah, hereby convey and warrant to Utah Power & Light Company, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alterations, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and no guys and 5 poles, with the necessary guys, stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantors, in Box Elder County, Utah, along a line described as follows:

Beginning on west boundary line of grantor's land at east fence line of county road

at a point 20 ft. south and 60 ft. east, more or less, from the west quarter corner of Sec. 4, T. 9 N., R. 2 W. S. L. B & M.; thence running N. 87°28' E. 118 Ft. thence No. 85° 38' E. 1151 Ft. to east fence line of said land and being in the north 1/2 of the SW 1/4 said Sec.4,

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
