IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a copy of this final order of condemnation be filed with the county recorder of Salt Lake County, State of Utah, and thereupon the property interests hereinafter referred to and set forth shall vest in fee simple title in the plaintiff. The following is a description of the property so ordered and condemned as hereinabove provided, which is hereby vested in fee simple title in the plaintiff, all of such property being situated in Salt Lake County, State of Utah, and is more particularly described as follows:

## Parcel No. 15-6:22

A parcel of land in fee for the relocation of the Union Pacific Railroad incident to the construction of a freeway known as Project No. 15-6, being part of an entire tract of property, in the NE4NE4 of Section 23, T. 4 S., R. 1 W., S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning on the south boundary line of said entire tract at a point 60.0 ft. radially distant westerly from the center line of the relocation of the Union Pacific Railraod approximately opposite Railroad Relocation Station 273+00.81, which point is also approximately 785.59 ft. west and 652.62 ft. south from the NE. corner of said Section 23; thence Northerly 415.07 ft., more or less, along the arc of a 6091.14-foot radius curve to the right to the north boundary line of said entire tract (Note: Tangent to said 6091.14-foot radius curve at its point of beginning bears approximately N. 14°02'01" E.); thence S. 89°27'37" E. 141.63 ft., more or less, along said north boundary line to a point 75.0 ft. radially distant easterly from said center line; thence Southerly 52.39 ft., more or less, along the arc of a 5956.14-foot radius curve to the left to a point opposite Railraod Relocation Station 269+00.0 (Note: Tangent to said 5956.14-footgradius curve at its point of beginning bears approximately S. 18°20'43" W.); thence S. 03°07'56" E. 101.67 ft.; thence Southerly 257.40 ft., more or less, along the arc of a 5931.14-foot radius curve to the left to said south boundary line (Note: Tangent to said 5931.14foot radius curve at its point of beginning bears S. 16°53'29" W.); thence N. 89°27'37" W. 164.67 ft., more or less, along said south boundary line to the point of beginning. The above described parcel of land contains 1.47 acres, more or less.

(Note: All bearings and distances used in the above description are based on the Utah State Plane Coordinate System.)

## Parcel No. 15-6:22B:A

A parcel of land in fee for a frontage road and freeway incident to the construction of a freeway known as Project No. 15-6, being part of an entire tract of property, in the NE4NE4 of Section 23, T. 4 S., R. 1 W., S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning on the south boundary line of said entire tract at a point 60.0 ft. radially distant westerly from the center line of the relocation of the Union Pacific Railroad approximately opposite Railroad Relocation Station 273+00.81, which point is also approximately 785.59 ft. west and 652.62 ft. south from the NE. corner of Section 23; thence Northerly 415.07 ft., more or less, along the arc of a 6091.14-foot radius curve to the right to the north boundary line of said entire tract (Note: Tangent to said 6091.14-foot radius curve at its point of beginning bears approximately N. 14°02'01" E.); thence N. 89°27'37" W. 84.54 ft., more or less, along said north boundary line to the existing easterly right of way line of the Union Pacific Railroad; thence Southerly 418.04 ft., more or less, along said easterly right of way line, which is also along the arc of a 2764.93-foot radius curve to the left, to said south boundary line (Note: Tangent to said 2764.93foot radius curve at its point of beginning bears approximately S. 21°35'07" W.); thence S. 89°27'37" E. 94.13 ft., more or less, along said south boundary line to the point of beginning. The above described parcel of land contains 0.85 acre, more or less.

(Note: All bearings and distances used in the above description are based on the Utah State Plane Coordinate System.)

Together with any and all rights or easements appurtenant to the remaining portion of said entire tract of property by reason of the location thereof with reference to said freeway, including, without limiting the foregoing, all rights of ingress to or egress from said remaining portion, contiguous to the lands hereby conveyed, to or from said freeway.
