AMENDMENT TO PROTECTIVE COVENANTS

WHEREAS, on the 2nd day of April, 1973, there was recorded in the office of the County Recorder of Salt Lake County, Utah, as Entry No. 2529134, in Book 3292, Page 10, a document entitled Declaration of Building and Use Restrictions for HIGATE HAMLET NO. 3, a subdivision, providing for the use and restrictions on use of the lots in said Higate Hamlet No. 3.

WHEREAS, it is deemed necessary and for the best interests of the subdivision and the occupants thereof that said protective covenants be amended to correct Paragraph 1, Part B, Residential Area Covenants.

NOW THEREFORE, the undersigned, being the owners of Higate Hamlet No. 3, as recorded March 29, 1973 as Entry No. 2528313, in Book NN at page 60, of the records of Salt Lake County Recorder of Salt Lake County, Utah, do HEREBY AMEND the Protective Covenants recorded in said Book 3292, Page 10, and hereinabove referred to as follows:

1. LAND USE AND BUILDING TYPE. No lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any lot other than one detached single-family dwelling not to exceed two stories in height and private garages and carports for not more than three vehicles, excepting therefrom Lots 1, 2, 3, 47, 48, 49, HIGATE HAMLET NO. 3, a subdivision, on which duplexes may be constructed. All construction to be of new materials.

Except as herein amended, all of the Protective Covenants as set forth in said Book 3292, Page 10, are hereby confirmed and approved.
