RIGHT-OF-WAY EASEMENT

The Undersigned Grantor (and each and all of them if more than one) for and in consideration of TEN DOLLARS AND NO/100----- dollars (\$ 10.00) in hand paid by the Grantees, the receipt whereof is hereby acknowledged, hereby grants, bargains and conveys unto The Mountain States Telephone and Telegraph Company, a Colorado corporation, the Utah Power and Light Company, a Maine corporation, and the Mountain Fuel Supply Company, a Utah corporation, Grantees, their successors, assigns, lessees, licensees and agents, a Rightof-Way Easement and the right to construct, operate, maintain and remove such communications, electrical and gas facilities together with the associated equipment, from time to time, as said Grantees may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to-wit: A seven foot (7') easement being 3 feet on either side of buried telephone, power and gas facilities on the following described property and as shown on the attached Exhibit "A:" Beginning North 0°02'30" West 1,427.25 feet and South 89°56'30" West 235 feet from the Southeast corner of Section 2, Township 2 South, Range 1 West, Salt Lake Base and Meridian; thence North 465 feet; thence North 6°46'05" West 195.05 feet; thence North 19° East 135 feet to the West bank of the Jordan River; thence North and parallel to the said river 350 feet more or less to the South line of the State Road; thence West and parallel to the State Road commonly known as 4700 South Street Expressway to the East line of Atherton Drive; thence South and parallel to the East line of the said Atherton Drive to the North line of Brammerton Drive, at which point is the Southwest line of the Grantor's property; thence Southeasterly 1,165.05 feet more or less along the said Brammerton Drive to the Easterly line of the Grantor's property; thence North 48° 297.91 feet; thence North 343.88 feet; thence West 105 feet more or less to the point of beginning. situate in the County of SALT LAKE, State of Together with the right of ingress and egress over and across the lands of the Grantor to and from the above-described property and the right to clear and keep cleared all trees and other obstructions as may be necessary.
