In consideration of the payment to the undersigned of the sum of \$10.00 and other good and valuable consideration receipt of which is hereby acknowledged the undersigned hereby grants, conveys, sells and sets over unto Professional United Builders Supply Incorporated, their successors and assigns a perpetual Easement over the following described real property situated in Davis County, State of Utah:

BEGINNING at the Northeast corner of the William A. McElrath property, said point being South 211.85 feet and East 1141.8 Feet from the Northwest corner of the SE $\frac{1}{4}$ of Section 24, Township 2 North, Range 1 West, Salt Lake Meridian and running thence West 113.0 feet to the East line of the Union Pacific Railroad Company Right of Way; thence North 21°55' East along said Right of Way 20 feet; thence East 157.35 feet to a point 20 feet East of the East line of the property conveyed to Wayne A. Ashworth and Jayne L. Ashworth, husband and wife, and Virginia B. Nester by Quit Claim Deed recorded as Entry No. 236568 in Book 242, page 582 of Official records; which property was in turn conveyed to Professional United Builders Supply, Inc., a corporation by Uniform Real Estate Contract; thence North 369.24 feet; thence North 21°55' East 20 feet more or less to the East line of said property; thence South 407.79 feet; thence West 50.48 feet more or less to the point of BEGINNING.

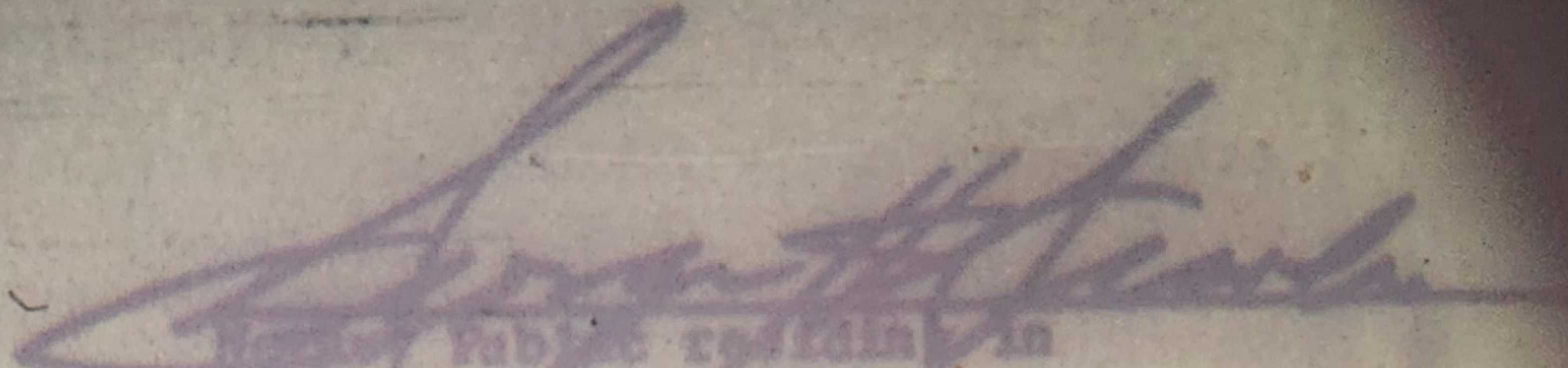

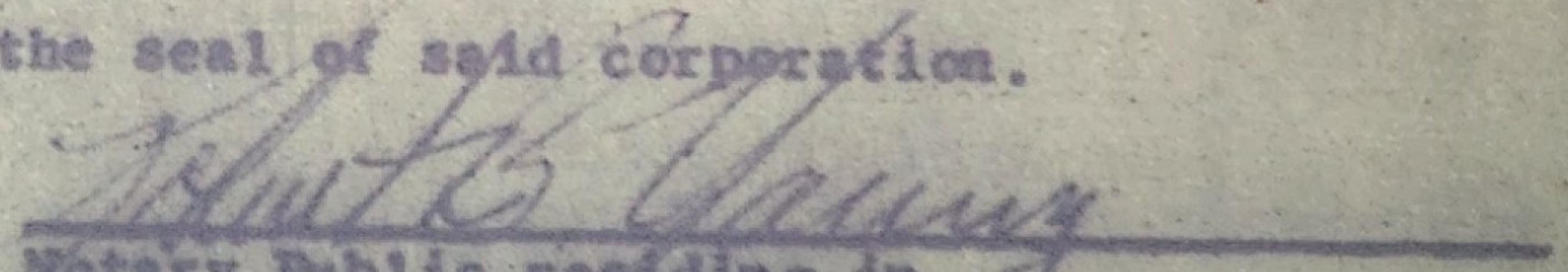
