SURVIVOR AFFIDAVIT,
CERTIFICATE OF IDENTITY & CERTIFICATE OF INCUMBENCY

ALVIN J. NOKER, hereinafter referred to as "Affiant", having been duly sworn, on oath, deposes and says:

1. That Affiant is over the age of eighteen (18), is a resident of Davis County, State of Utah, is competent to testify to the matters herein, and does so from personal knowledge.
2. That Affiant is the Successor Trustee to THE NOKER FAMILY TRUST dated the 10th day of May, 1993, and that up until the date of her death, LORA LEE NOKER was a Co-Trustee of said trust agreement.
3. That LORA LEE NOKER aka LORA LEE MARSHALL NOKER died on the 17th day of February, 2003; a certified copy of the death certificate acknowledging her death is attached hereto and by reference made a part hereof.
4. That ALVIN J. NOKER and LORA LEE M. NOKER conveyed any and all interest in the below-described property into THE NOKER FAMILY TRUST by a certain Quit Claim Deed recorded June 11, 1993, as Entry No. 1041428, Book 1625, Page 801, covering the following property situated in Davis County, State of Utah:

5. That LORA LEE MARSHALL NOKER, named as the deceased in the certified copy of the death certificate hereto attached, is the same person as LORA LEE NOKER named in said Quit Claim Deed above referred to.
6. That by reason of the death of LORA LEE NOKER, and pursuant to Article VIII of said Trust Agreement, the Affiant, ALVIN J. NOKER, has become the Successor Trustee of THE NOKER FAMILY TRUST, dated the 10th day of May, 1993.
7. That the Affiant does hereby accept the incumbency to serve in said capacity as Successor Trustee of said Trust; that by reason of the death of LORA LEE NOKER, and the terms of said Trust Agreement, Affiant as Successor Trustee and with the power and authority vested in him by reason of said Trust, does accept the above-described property as Successor Trustee of said Trust Agreement and the position of Successor Trustee and agrees to perform all duties and functions according to said trust instrument.

The Undersigned, as Successor Trustee of THE NOKER FAMILY TRUST dated the 10th day of May, 1993, does hereby remove the name of LORA LEE NOKER, Trustee of THE NOKER FAMILY TRUST and said property shall be titled from this date forward as: ALVIN J. NOKER, Trustee or Successor Trustees of THE NOKER FAMILY TRUST, dated the 10th day of May, 1993, of Bountiful, County of Davis, State of Utah.

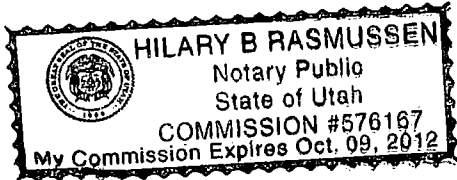
