

RIGHT OF WAY AGREEMENT FOR

2695534 SANDY SUBURBAN IMPROVEMENT DISTRICT, PIPE LINE

Morris E. Barnes and Gladys Barnes,  
his wife, of Sandy, State of Utah, Grantors, do hereby con-  
vey and warrant to the Sandy Suburban Improvement District, Salt Lake County, Utah, organ-  
ized and existing under and by virtue of the laws of the State of Utah, Grantee, for \_\_\_\_\_

\_\_\_\_\_, a right of way and easement for the  
purpose of digging a trench along said right of way, and to lay, maintain, operate, repair,  
remove or replace the pipe line for transportation through and across the Grantors land and  
premises in Salt Lake County, State of Utah, and located in:

Comm 42 feet East and 304.5 feet North from SE Cor, Sec1, T3S, R1W,  
SL Mer.; thence North 70.3 ft; West 355.8 feet to canal; SW'ly along  
Canal to a point due West of Beg.; East 362.9 feet to beg.

the center line of said pipe shall extend through and across the above land and premises on a  
line described approximately as follows:

125 feet, more or less, west of the East property line.

TO HAVE AND TO HOLD the same unto the Sandy Suburban Sanitary District so long  
as such pipe line shall be maintained, with the right of ingress and egress to and from said  
right of way, and to maintain, operate, repair, remove or replace the same. The said  
Grantor\_\_ to fully use the said premises except for the purposes for which this right of way or  
easement is granted to the said Grantee.

The rights hereby granted are subject to the condition that Grantee shall compensate  
Grantor at a reasonable appraised valuation for any damages done to Grantor's land or crops  
caused by Grantee in the construction, maintenance, repair and operation or replacement of  
said pipe line.
