

RIGHT OF WAY AGREEMENT FOR

his wife, of 269 West 3rd No Salt Lake City, State of Utah, Grantors, do hereby convey and warrant to the Sandy Suburban Improvement District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for

_____ a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:

Commencing 123.44' North and 1297.35' East from Corner Section #1, T3S, R1W, S. L. Mer. South 89°53' thence West 984.65'; North 0°13'06" ~~thence North~~ 567.19'; North 89°53' ~~thence East~~ 984.65'; South 0°13'06" ~~thence Southwest~~ 567.19' to Beginning.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:

Center Line of Sewer to be located 125'± East of the Southwest Corner thence running through and across to a point 120' South of the Northwest Corner of property and along proposed frontal road for Interstate Highway Interchange.

Note Save top Soil Mrs Reid would like Surplus Fertilizer to be placed 200' East Sewer line & Side of Property.

TO HAVE AND TO HOLD the same unto the Sandy Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.

The rights hereby granted are subject to the condition that Grantee shall compensate Grantor at a reasonable appraised valuation for any damages done to Grantor's land or crops caused by Grantee in the construction, maintenance, repair and operation or replacement of said pipe line.

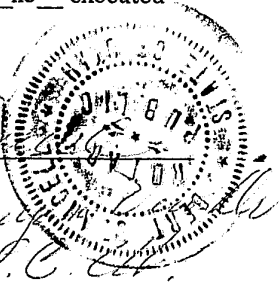
