**CROSS EASEMENT AGREEMENT
FOR PEDESTRIAN AND VEHICULAR TRAFFIC**

THIS AGREEMENT is made and entered into this 18 day of Sept.
2008, by and between Brigham City Corporation, a municipal corporation, (hereinafter
"Grantor") and Nathan B. Moss and Vida C. Moss, (hereinafter "Grantee(s)").

RECITALS

WHEREAS, Grantor is in possession of land located west and adjacent to State Road 89, more fully identified as Parcel No. 03-142-0023, attached hereto and made a part by reference, as Exhibit "A"; and

WHEREAS, Grantee(s) are in possession of land located west and adjacent to State Road 89, more fully identified as Parcel No. 03-142-0073, attached hereto and made a part by reference, as Exhibit "B"; and

WHEREAS, Utah Department of Transportation would like to discourage direct access onto State Road 89 from Grantee(s) parcel; and

WHEREAS, Grantor desires to more fully implement a safer access for Grantee(s) parcel by allowing Grantee(s) pedestrian and vehicular access through Grantor parcel; and

WHEREAS, Grantee(s) understand and acknowledge as conditions necessitate Grantor may, at some future date, amend Snow Orchard Plat, Lots 3, 4, and 5, to allow better utilization of the lots; and

WHEREAS, Grantee(s) further understand and agree as the subdivision is amended this action may require a relocation or modification to the terms of this agreement.

NOW THEREFORE, for and in consideration of the promises, covenants, terms and conditions hereinafter set forth, Grantor and Grantee(s) agree as follows:

1. Grantor hereby grants to Grantee(s) a Cross Easement for Pedestrian and Vehicular Traffic across the west twelve (12) feet of Grantor parcel as defined in Exhibit "A".
2. Grantee(s) understand and acknowledge as conditions necessitate Grantor may, in the future, amend Snow Orchard Plat, Lots 3, 4, and 5, to allow better utilization of the lots.

3. Grantee(s) further understand and agree as the subdivision is amended this action may require a relocation or modification to the terms and conditions of this agreement.

This agreement is binding upon and inures to the benefit of the respective parties hereto, their successors, heirs, and assigns.


Grantor hereby execute this agreement after having received authority to do so by its governing body.






