The State of Utah, acting through the BOARD OF WATER RESOURCES, GRANTOR, for the full payment of the purchase price of Agreement, dated August 14, 1973, with the CENTRAL UTAH WATER CONSERVANCY DISTRICT, receipt of which is hereby acknowledged, hereby transfers and conveys to the CENTRAL UTAH WATER CONSERVANCY DISTRICT, a political subdivision of the State of Utah, GRANTEE, the following described tracts of land in the County of Salt Lake, State of Utah:

Part of the SE $\frac{1}{4}$ of Sec. 17, T4S, R1W, SLB&M. Beg. at a point on the section line 2,643.63 feet S 0°26'31" W, and 700.0 feet S 0°24'16" W, of the NE corner of said Sec. 17, thence along said section line S 0°24'16" W, 300.0 feet, thence N 89°35'44" W, 550.0 feet, thence N 0°24'16" E, 300.0 feet, thence S 89°35'44" E, 550.0 feet to the point of beginning.

Together with all improvements thereon and appurtenances thereto.

Part of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Sec. 16, T4S, R1W, SLM. Beg. at a point on the $\frac{1}{4}$ section line 2,643.63 feet S 0°26'31" W, and 1,322.15 feet S 89°53'01" E, of the NW corner of said Sec. 16, thence N 0°24'32" E, along the 40 acre line 814.25 feet m/l, to the S bank of the Provo Reservoir Company Canal, thence SEly along the canal bank as follows: S 73°40'34" E, 75.96 feet; thence S 58°54'21" E, 842.40 feet, thence S 74°50'52" E, 542.36 feet, m/l, to the E line of the NW $\frac{1}{4}$ of Sec. 16, thence S 0°22'33" W, 218.75 feet, thence N 89°53'01" W, 1,322.15 feet to the point of beginning.

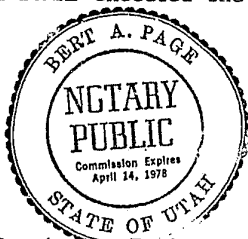


