

2. All irrigation system improvements and physical facilities constructed under the said agreements and related documents located in Section 5, T6N, R2W, SLB&M.



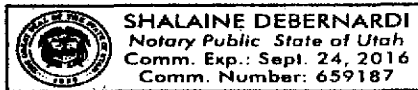
