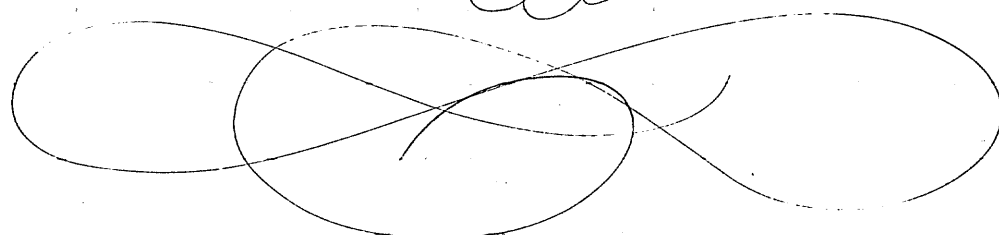

Grant of Right of Way.

R. P. Fairbanks an unmarried man, grantor, of Provo, County of Utah, State of Utah, for the sum of One Dollar and other valuable considerations, is grantor in hand paid by Knight Power Company, a corporation, grantee, of Provo, Utah County, State of Utah, hereby grants to the said Knight Power Company, its successors and assigns, a right-of-way to erect and maintain a line of poles for an electric transmission line or circuit, as now located, over and across the following described tract of land situate, lying and being in Utah County, State of Utah, to-wit:

The east half of the east half and the northwest quarter of the northeast quarter of section 2, township 6 south, range 1 west, Salt Lake base and meridian.

The course of said transmission line over and across the above described premises to be as follows:

Commencing at a point $1400 \pm$ feet west of the northeast corner of section 2, township 6 south, range 1 west, Salt Lake base and meridian, thence south $12^{\circ} 39'$ east $5400 \pm$ feet to a point $200 \pm$ feet west of the southeast corner of section 2, where line crosses south boundary line of said section.

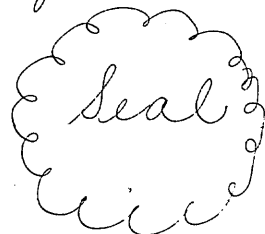

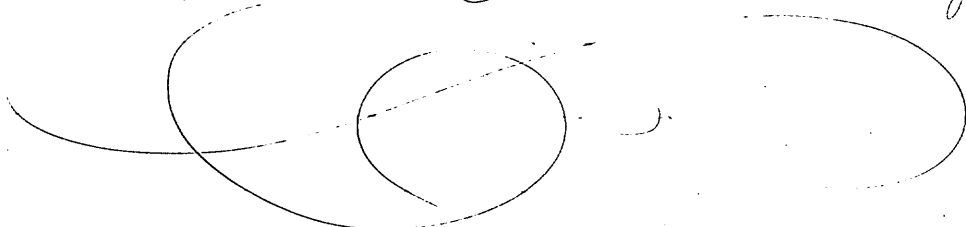
