The above entitled matter came on regularly for hearing before the Honorable Stewart M. - 1. That the complaint of Clifford M. Johnson and Marion C. Johnson against Westerners, Inc., and Don E. Petersen and Clarence E. Petersen be, and the same is hereby dismissed without prejudice.
- 2. That the complaint of Clifford M. Johnson and Marion C. Johnson against Wayne G. and Betty Wardle be, and the same is hereby dismissed with prejudice, the court finding in favor of the defendants and against the plaintiffs, No Cause of Action.
- 3. That the cross-complaint of Westerners, Inc., against the cross-defendants Wayne G. and Betty Wardle be, and the same is hereby dismissed with prejudice, the court finding in favor of the cross-defendants and against the cross-plaintiff, No Cause of Action.
- 4. It is further adjudged that the defendants Wayne G. and Betty Wardle are the owners in fee simple of that property located in Salt Lake County, State of Utah, and more particularly described as follows:

Commencing at a point on the East boundary line of 700 West Street, said point being 291. 45 feet South of the Northwest Corner of Lot 4, Block 13, 10 Acre Plat A, Big Field Survey, and running thence North 89° 57' East 759 feet more or less to the East Line of Lot 4, Block 13, Section 36, Township 1 South, Range 1 West, Salt Lake Meridian, and running thence South 80 feet; thence South 89° 57' West 759 feet more or less to the East boundary line of 700 West Street; thence North 80 feet to the point of beginning.
