ORDINANCE

AN ORDINANCE OF THE COUNTY OF SALT LAKE CREATING THE BUTTERFIELD AND ROSE CANYONS PLANNING DISTRICT, ADOPTING THE UNIFORM ZONING ORDINANCE OF SALT LAKE COUNTY, UTAH, FOR THE BUTTERFIELD AND ROSE CANYONS PLANNING DISTRICT, ADOPTING A ZONING MAP FOR THE BUTTERFIELD AND ROSE CANYONS PLANNING DISTRICT AND AMENDING SECTION 22-8-4 OF THE REVISED ORDINANCES OF SALT LAKE COUNTY, UTAH, 1966.

The Board of County Commissioners of Salt Lake County State of Utah ordains as follows:

Section 1: That Pursuant to Title 17, Chapter 27, Section 11, Utah Code Annotated, 1953, the Butterfield and Rose Canyons Planning District is hereby created and is legally described as follows:

Beginning at the northeast corner of Section 3, T.4S., R.2W., SLB&M, thence west following along the section lines to the Salt Lake County Boundary line; thence southeasterly following along the Salt Lake County Boundary line to the intersection of said boundary and the east section line of Section 22, T.4S., R.2W, thence North following along the Section lines to the point of beginning.

Section 2: That the uniform zoning ordinance of Salt Lake County, Utah, also known as Title 22, Revised Ordinances of Salt Lake County, Utah, 1966, and as amended is by reference adopted for the Butterfield and Rose Canyons Planning District.

Section 3: That the Butterfield and Rose Canyons Planning District is hereby zoned as shown on the attached map entitled "Zoning of Butterfield and Rose Canyons Planning District".

Section 4: That Section 22-8-4 of the Revised Ordinances of Salt Lake County, Utah, 1966, as amended, be amended by adding Butterfield and Rose Canyons Planning District.

Section 5: That the attached map referred to shall be incorporated in and at the end of Title 22, Revised Ordinances of Salt Lake County, Utah, 1966, as amended, and by this reference made as much a part of Title XXII, Revised Ordinances of Salt Lake County, Utah, 1966, as amended, as if fully described in detail herein.

Section 6: In the opinion of the Board of County Commissioners it is necessary for the immediate preservation of the peace, health and safety of the County and the inhabitants thereof, that this ordinance should take effect immediately upon publication in one issue of a newspaper published in and having general circulation in Salt Lake County.

IN WITNESS WHEREOF, the Board of County Commissioners has approved, passed, and adopted this ordinance this 4th day of August, 1975.

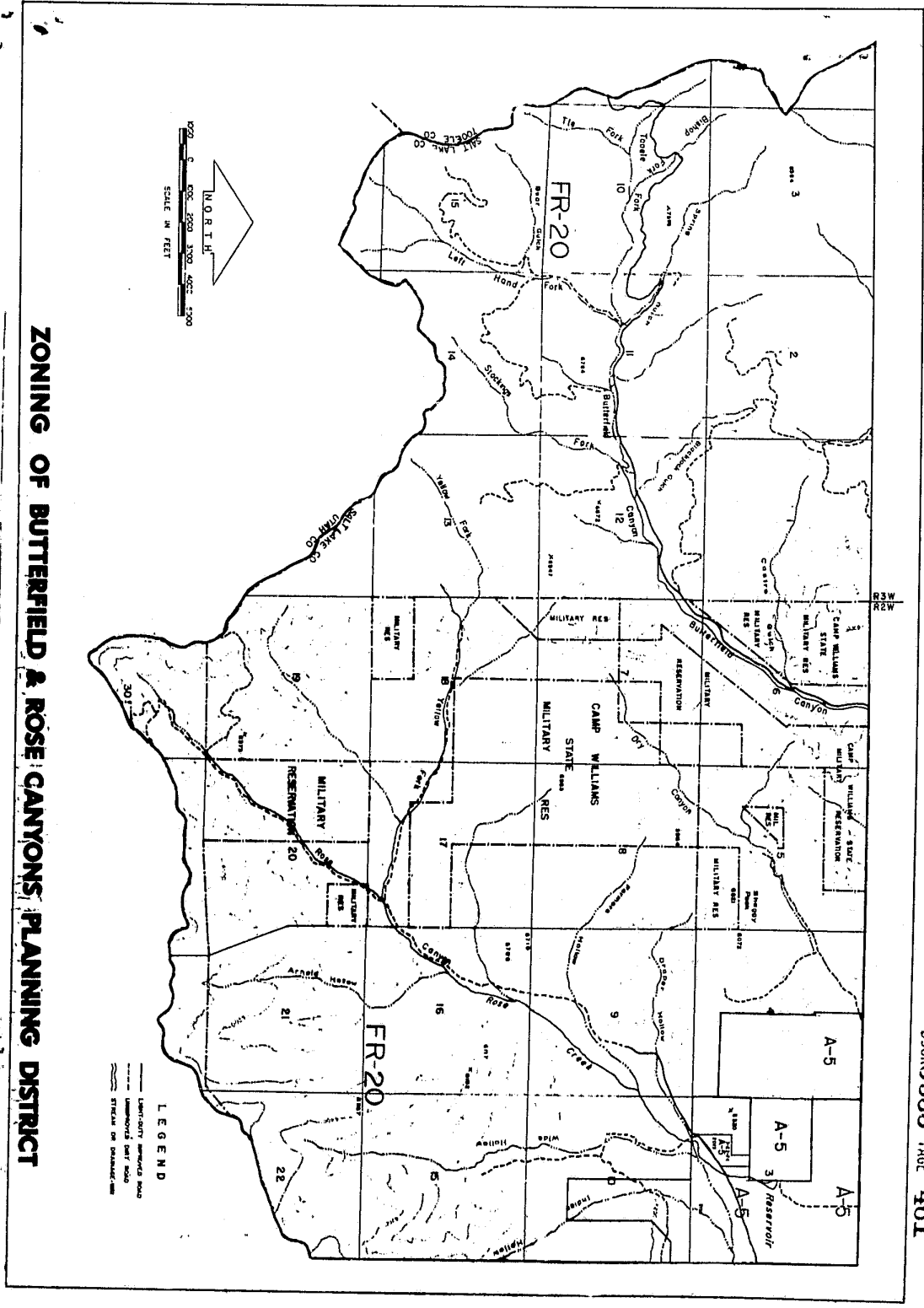

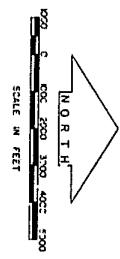
