DECLARATION FOR CHANGE OF RESTRICTIVE COVENANTS ON INTERNATIONAL BUILDING ASSOCIATION SUBDIVISION TOOELE, UTAH

WHEREAS, on the 21st day of August, 1939, Charles A. McBride, President and W. H. Floyd, Secretary, of the International Building Association, and Estel L. Wright and F. J. Bradshaw, as the President and Secretary, respectively, of American Mutual Building & Loan Association duly executed and thereinafter placed of record in the office of the County Recorder of Tooele County, Utah, an instrument in writing wherein they made a dedication of the Plat of said INTERNATIONAL BUILDING ASSOCIATION SUBDIVISION in Tooele City, Tooele County, State of Utah, and

whereas, in the above mentioned dedication the said officers of the respective companies made and recorded, with said dedication, certain restrictive covenants regulating the rights of owners of the respective parcels of real property in said subdivision, and those covenants were set forth in Sections 4 to 16, inclusive in such instrument so executed and placed of record, as aforesaid, and

whereas, it was specifically provided by the terms and provisions of Section 14 of such restrictive covenants as follows, "These covenants, agreements and restrictions shall remain in force until January 1, 1965, at which time said covenants will automatically be extended for periods of ten years unless by vote of the title holders of record of 55% of the land in said subdivision it is agreed to change or abandon said covenants or restrictions in whole or in part. Said vote must be taken at least 10 days prior to the day that any of the above terms expire and not earlier than six months prior to the day upon which any of the above terms expire", and

WHEREAS, because of a substantial change in conditions in Tooele City, Utah, since the date of the making and filing of said covenants and restrictions, it now appears to be just and reasonable to change such covenants and restrictions as set forth in such instrument so recorded as hereinafter provided.

BE IT NOW THEREFORE, declared and resolved as follows:

That, we the undersigned, being owners of record of land in the INTERNATIONAL BUILDING ASSOCIATION SUBDIVISION IN Tooele City, Tooele County, State of Utah, as shown by the Plat of said Subdivision, heretofore made and filed in the office of the County Recorder of Tooele County, State of Utah, and we collectively being the owners of more than 55% of the lands involved in said Subdivision, do by these presents hereby declare and resolve; that Sections IV, V, VI, VII, VIII, IX, X, XI, XIII, XIV, XV and XVI and the provisions therein contained and set forth are no longer beneficial to the proper use of lands within said Subdivision and are hereby declared to be vacated, terminated, set aside and abandoned, and determined to be no longer in force and effect after the 1st day of January, 1965.

It is hereby further declared and resolved that in place of said covenants and restrictions herein vacated that the use of the lands within said Subdivision be regulated and controlled in conformity with the present Zoning Ordinances of the City of Tooele and said lands be regulated specifically by the provisions set forth in such Zoning Laws of the City of Tooele as relating to an RI-A zoning area.
