DECLARATION OF INCLUSION

(River Run Plats "D", "E", "F" & G)

This DECLARATION OF INCLUSION ("Declaration of Inclusion") is made by RIVER RUN SF, LLC, a Utah limited liability company ("Declarant") to be effective as of the date set forth on the signature page.

RECITALS

A. Declarant is the developer of a master planned residential subdivision known as "River Run" or "River Run Townhomes" ("Project") located in the City of Spanish Fork ("City"), Utah County ("County"), State of Utah. The Project is more particularly identified in the Declaration (defined below).

B. Declarant previously caused that certain *Amended and Restated Declaration of Covenants, Conditions, and Restrictions for River Run* to be recorded in the real property records of Utah County on June 18, 2024, as Entry No. 39854:2024 ("Declaration").

C. The River Run Townhomes Owners Association ("Association") has been incorporated as a Utah non-profit corporation to act as a homeowners association for the Project with the powers, duties, rights, and obligations set forth in the Declaration.

D. Section 2.38, Section 3.2, and Section 27.1 of the Declaration provide that the Project may be expanded to include additional real estate within the scope of the Project ("Expansion Property") and that, upon recording a declaration of inclusion, such Expansion Property will become subject to the Declaration and the covenants set forth therein.

DECLARATION

NOW, THEREFORE, Declarant adopts the following covenants, conditions, and restrictions with respect to the Expansion Property:

1. Recitals Incorporated. The foregoing recitals are incorporated into this Declaration of inclusion.

2. Definitions. Capitalized terms used herein but not otherwise defined have the meaning provided in the Declaration.

3. Expansion of the Project. The Project is hereby expanded to include the Expansion Property described on Exhibit A, attached hereto and by this reference incorporated herein. The Expansion Property shall henceforth be included in the Property and subject to the Declaration, all amendments to the Declaration adopted thus far, and all amendments to the Declaration adopted hereafter.

4. Membership in the Association. As set forth in Section 2.6 of the Declaration, each Owner of a Unit within the Property will be a Member of the Association, with all the rights, privileges, benefits, duties, and obligations associated with membership in the Association as set forth in the Declaration.

5. Declarant's Rights. Nothing in this Declaration of Inclusion shall be deemed to impair or limit any of Declarant's rights as set forth in the Declaration, all of which will be applicable to the Expansion Property.

6. Notice of Reinvestment Fee. A *Notice of Reinvestment Fee Covenant* has been recorded against the Property or will be recorded against the Property. The Property will be subject to the Reinvestment Fee described therein.

7. Recording. This Declaration of Inclusion shall be recorded in the Utah County Recorder's Office against the Property.
