

RIGHT OF WAY AGREEMENT FOR

SALT LAKE CITY SUBURBAN SANITARY DISTRICT PIPE LINE

Grant S. and Jeanne L. Kesler, et al

of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of \$1.00

and other consideration DOLLARS (\$1.00) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:

- Tract 1: Beg at a point 186.62 ft S of NW cor of lot 3, blk 21, 10 Ac Plat "A" Bg Fld Sur, runn. thence S 100.49 ft; th E 759.00 ft; th N 100.49 ft; th W 759.00 ft to the point of beg.
Tract 2: Beg. at NE cor of S 1/2 of Lot 3, Blk 21, 10 Ac Plat "A", Bg Fld Sur, said point being described as 759 ft E & 287.1 ft N from the SW cor of Lot 3 & runn. th S 287.1 ft; th W 110 ft; th N 7 ft; th N 89°58'40" W 59.86 ft; th N 157 ft; th W 259.64 ft; th N 123.1 ft th E 429.5 ft to point of beg. Subject to & together with a Rt-of-Wy over & across the following prop.: Beg at a point 164 ft N from the SW cor of Lot 3 Blk 21, 10 Ac plat "A" Bg Fld Surv & runn. th N 30 ft; th E 759 ft; th S 30 ft; th W 759 ft to the point of beg.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:

All main sewer lines which will serve two or more buildings, width of easement to be 5 ft each side of center line of pipe.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor... to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.

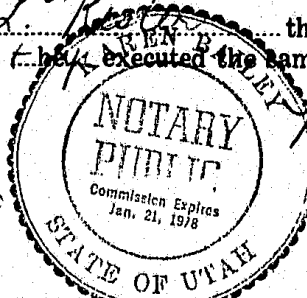
