

Erastus Johnsen and wife Nellie M. Johnsen grantors of Richmond,, County of Cache, State of Utah, hereby CONVEY and WARRANT to Cache County, a Public Corporation of the State of Utah grantee of Cache County, Utah for the sum of Seven hundred and fifty dollars the following described tract of land in Cache County, State of Utah:

Commencing at a point in the North line of a right-of-way, which right-of-way is known as the Thomas H. Hendricks, right-of-way, said point of beginning is further described as being 113.5 feet North and 141.10 feet West from the East Quarter Corner of Section 14, Township 14 North, Range 1 East of the Salt Lake Base and Meridian, and running thence N 13° 55' W 4.522 chains; thence N 32° 20' W 1.775 chains; thence S 66° 30' W 2.584 chains; thence S 67° 15' W 8.089 chains; thence S 40° 06' W 1.10 chains, which point is in the North line of the said Hendricks right-of-way at a point 1137 feet, more or less, West of the point of beginning; thence East along the North line of said right-of-way 1137 feet, more or less, to the point of beginning, containing in all 5.10 acres, more or less.
